## 4. What exactly is an Anti-Semite?

- The term anti-Semite came into prominence in the years 1879-1881.
- Traditionally, anti-Semitism was said to be hostile discrimination of Jews as a religious or racial group
- Officially today, “Antisemitism is prejudice against, or hatred of Jews.” – Definition of the U.S. Holocaust Memorial Museum
- The definition of anti-Semitism is gradually expanding, e.g., the U.S. State Department now describes Holocaust-denial as a form of antisemitism.

It must be said at the start that nobody can question this topic without some degree of stigma resulting from instilled fear or guilt from life-long media indoctrination. It may be difficult for many to shake off this apprehension and clearly consider the actual facts presented in this chapter with a neutral mind.

The term Anti-Semite became popularized when a German, [Wilhelm Marr](#), founded the *League of Antisemites* in 1879.<sup>1</sup> This was a restless time when Jewish Marxists were busy creating the people’s German Social Democratic Party in 1875, as well as the Socialist Revolutionary Party in Russia. There was a terrorist arm<sup>2</sup> to these Jewish movements which resulted in the assassination of Russia’s Alexander II in 1881 by the Jewish revolutionaries. Jewish terrorists were at the forefront of killing numerous high level Czarist officials during the period of Alexander’s murder up until 1906.<sup>3</sup>

Given today’s new expanded definition, an anti-Semite could be:

- 1) a bad person with a bad heart who hates Jewish people, or may threaten or even kill Jewish people, or
- 2) a good person with a good heart seeking peace for all, but *asking questions* about Jews or Israel, or the Holocaust.

### **Quoting *Encyclopaedia Judaica* or the *Book of John* is Anti-Semitic**

Obviously, the new official definition of anti-Semitism is very problematic. It can create anti-Semitism where none exists—obviously that is by design. For instance, if you quote the *Encyclopaedia Judaica* where it states *Jews control many aspects of the media*, then ironically by the new definition, you become an anti-Semite for quoting a Jewish encyclopedia. The new definition can shame anyone who seeks to understand or critically evaluate any Jew, any aspect of Judaism, or any action of the militant Jewish state.

Even the Catholic Church has recently warned its flock that if they are not careful, they could become anti-Semites by reading the gospel book of John, according to Dr. E. Michael Jones. In John's book, primarily in chapter 8, Jesus reprimands the Pharisees of Judea at length. This church warning is a striking example of Jewish influence over the Catholic Church.

### **Steps to Become an Anti-Semite**

- Hearing the word *Jew*
- Hearing comments about Jews
- Noticing Jews in any context
- Thinking about various types of Jews or who they are
- Asking questions about Jews in general
- Asking about Jewish history or ethnicity
- Asking about so-called "Jewish power"
- Thinking, reading, talking and writing about Jews, the Holocaust, Jews in the media, Hollywood, banking, etc. You are now an anti-Semite regardless of your love, hate, or indifference toward Jews.

According to Gilad Atzmon, the *ultimate Jewish power* is "the unique capacity to silence any discussion of Jewish power."

## The Term “Anti-Semite” as a Psyop Weapon

The word *Anti-Semite* can be hurled by the enemy as a verbal spear. The term can defame a speaker, injure his reputation, and stop his speech—if he allows it by honoring the enemy’s intent.

“Anti-Semite” is simply one of many psyop terms used in the psychological operation of thought control. The operators apply the term to anybody saying anything they don’t want publicized. If what you are writing or saying does not align with their agenda, then they select a psyop term to shame you and block your communication.

The key to neutralizing these control words of shame is to call them out immediately as psyop words. We could say, “That’s just one of your psyop terms to shut down my free speech on the facts!” We then explain that we know they are trying to shut us down because they don’t want to discuss facts that could expose their deceptive narratives.

Now we all know that purposely *false*, *malicious*, and *hateful* statements about Jews or Jewish history are truly evil and inhumane. Sometimes, however, innocent remarks are taken badly and challenged. Therefore, as students of history and society, we must avoid emotional judgments of opinion and stick to facts alone. We must carefully seek truthful evidence and *also verify and document that evidence* in order to gain the most accurate and complete view of the truth. Anti-Semitism is based on hate. Hate stems from emotions and ignorance. Therefore, choosing to think peacefully and objectively with hard facts and evidence, we can side-step truly hateful anti-Semitism!

When we post or publish any information it should be done with courtesy with the sole intent to enlighten others; information should be factual, not emotional—keep in mind that one-upmanship does not serve truth or peaceful co-existence! Louis Brandeis, the first Jewish Supreme Court justice, spoke about how to deal with offensive speech in the case *Whitney v. California*. He said,

“Expose through *discussion* the falsehood and fallacies, to avert the evil by the process of *education* . . . the remedy to be applied is more speech, not enforced silence.” (Emphasis added)

— Justice Louis Brandeis

This is what this inquiry is about: discussion, education, and more speech, of course with courtesy foremost.

### **Taking a Stand: An Example**

Now whenever we take a position with facts, any position, it will be opposed by someone. When our opponent offers opposing facts, we have a conversation, but when our opponent offers only declarations, judgments, opinionated words and no facts or sources, then we must repeat our facts and cite our sources of authority.

We might state our position as:

Jews own and control the media.

Our position is easily attacked because it has no factual support. Facts will solidify our position greatly, as the revision below:

## The Truth According to ChatGPT

ChatGPT is a new online application that answers questions. When asked about Jews and the media it gives information contrary to the *Encyclopaedia Judaica*. This looks like more evidence the enemy controls the media as well as ChatGPT and most online content.



Do Jews run the media?

**Chat GPT is programmed to lie. The answer below contradicts the *Encyclopaedia Judaica*.**



No, the notion that Jews run the media is a baseless anti-Semitic stereotype. The media industry, like any other industry, is comprised of individuals from diverse backgrounds, including people of different races, religions, and ethnicities. To suggest that any one group controls the media is false and undermines the hard work and talent of individuals in the industry. It also perpetuates harmful conspiracy theories that have been used to justify discrimination and violence against Jews and other minority groups.

Not so, says the *Encyclopaedia Judaica*, 2<sup>nd</sup> Ed., Vol. 19, p. 594.

It's not farfetched to imagine that ChatGPT will be our new arbiter of truth, of morals, and worthiness. ChatGPT will gladly write student papers and soon non-thinking students, even doctors, will merge into the programmed matrix of the New World Order. In theory, AI equals Artificial Intelligence. In practice, it is Autocratic Indoctrination. ChatGPT will become the new Wikipedia, a database of facts mixed with skewed and politicized dogma of the New World Order. Remember, GIGO is garbage in, garbage out.

“The media has a great influence on people’s thoughts. It was previously in the hands of sovereign governments, but it is now under our control . . . through the media we have gained the power of influence while remaining invisible.”

— The Protocols of the Learned Elders of Zion (from Protocol II)

Truth depends on objective details and facts (and verification of those facts)—like the Wikipedia source mentioned above with 379 footnotes; however, propaganda needs only emotionally-toned words and popular slogans, or just plain lies like the ChatGPT answer above. Since words can carry both information and *feeling*, emotionally-toned words and phrases are often used by your opponent to cloud or block factual reasoning. Today’s official propaganda is often weighted with feelings, but light on facts.

## Anti-Semite is a Problematic Term

The term *anti-Semite* is an emotionally-toned word—and its expanded definition radiates judgment on the guilty as well as the innocent. Its new definition challenges the First Amendment by unfairly labeling those with inquiring minds as hateful people.

Semite – (noun) a member of any of the peoples who speak or spoke a Semitic language, including the Jews, Arabs and Assyrians.

Anti-Semite is an inappropriate word if used to refer to Jews because the term refers to all Semites, including non-Jews such as Arabs (e.g., Palestinians). Also, it is generally recognized that many so-called Jews in Israel and elsewhere are of Khazarian lineage, known as Ashkenazi, and not actually Semites of the direct lineage of Shem, Eber, and Jacob (Israel).

If most Jews are from Europe and not Semites, then how can “antisemite” be used in reference to Jews? *Anti-Semite* is a misnomer as it does not refer to the so-called (European) Jews currently in Palestine.

The real “anti-Semites” were the migrating Jews who early in the 1920s and 30s began taunting the Arabs (Semites) in Palestine, ironically calling them “anti-Semites.” The author Gudrun Krämer explains how this occurred in the 1930s in her book, *A History of Palestine*:

**Some Zionists tried to discredit Arab resistance to their goals as an expression of anti-Semitism that they claimed was rooted in Islam itself. Arab resistance was thus depoliticized, transposed onto a racist plane tied to religion, and robbed of moral legitimacy.**

Let’s take a look at the words of the author above. She states that when the Jews first entered Palestine in a militant fashion, they immediately accused the native defenders of religious and racial hatred, i.e. *anti-Semitism*. This psyop tactic allowed the Jews to discount their wrongful aggressive invasion and place blame for the conflict on the existing native population merely defending their homeland. Using the psyop term *anti-Semite!* is the hallmark, classic tactic of the Jews to twist the facts and deflect blame.

The lineage of the European Jews is mainly Ashkenazi—a mix of non-Israelite peoples—non-Semites! According to the Jewish scholar and statesman Benjamin Freedman, these European Jews were an Asiatic Mongoloid nation, classified by modern anthropologists as Turco-Finns racially; first living 1700 years ago in what is now present-day Ukraine.



Amazingly, this was corroborated by Rabbi Menachem Schneerson when he admitted:

“Looking back in history, it must be admitted that these lands are the ancient ancestral lands of the Jewish Khazaria, that is Israel, captured by Kiev's Rus' — the ancient state of Russia with the capital in Kiev — in the tenth century.”

More support for this is found in *The Jewish Encyclopedia* where they say:

“Some anthropologists are inclined to associate the racial origin of the Jews, not with the Semites, *whose language they adopted*, but with the Armenians and Hittites of Mesopotamia, whose broad skulls and curved noses they appear to have *inherited*.”

(*The Jewish Encyclopedia*, X: 284. Article on “Purity of Race”)

It is truly ironic that *the biggest anti-Semites are the so-called Zionist Jews* running the government in Israel. These Israeli Zionists imply they are Semites, yet most are immigrants or descendents of *Europeans* that originated from Ashkenazi tribes of ancient Khazaria, near Ukraine. These European immigrants to Palestine have always been quite anti-Semitic toward their neighboring Palestinians who claim to be true Semites in their native land.

Non-Semite Zionists use their power to severely punish and terrorize native indigenous Semite people of Judea, Gaza, and the West Bank, the Palestinian people. (More on this in Chapter 5, *What is Zionism?*) We have established that the real identity of most Jews is mixed European, but for simplicity and discussion we will accept the misnomer *Semite* to apply to all so-called Jews and those identifying as Jews.

According to the New Anti-Semite Laws

Hating = Anti-Semitism

Not hating but questioning = Anti-Semitism

### **A Proliferation of Anti-Semitism Expressions**

All agree that the core of anti-Semitism is hate. The problem is that people who are not hateful and do not hate Jews are now being placed in the “anti-Semite group” due to a greatly expanded official definition of anti-Semite. This is a huge problem! This is being promoted by governments and schools worldwide. They have adopted this expanded definition of anti-Semitism due to pressure by the *International Holocaust*

*Remembrance Alliance* (IHRA) and the U.S. State Department and its Jewish leadership.

Strange but true, even the word “Jew” might be interpreted by some Jews as being anti-Semitic. According to the *Encyclopaedia Judaica*, “the use of ‘Jew’ [can be used] in the pejorative sense, along with ‘Yid,’ ‘Sheeny,’ ‘Ikey’ and the like.”†

Today powerful bureaucrats are taking “anti-Semitism” beyond prejudice, beyond hate, and beyond violence to include simple questioning, and even mental perceptions and beliefs. For instance, if you merely think the government’s Holocaust narrative has some conflicting facts that could be researched further, then you are anti-Semitic.

The IHRA and state laws provide specific examples of anti-Semitic beliefs or expressions as listed below. If you think about any of these, you are officially anti-Semitic:

- *A world Jewish conspiracy . . .*
- *Jews control the media or Hollywood*
- *Jews control the economy*
- *Jews control the government*
- *Jews control societal institutions*
- *Jews . . . invented or exaggerated the Holocaust*

All the above are officially false—yet how can we “fact check” these allegations if we don’t ask questions, verify, and get “reasons why” by doing our own research?

Why is there vagueness in all the statements above? For instance, Jews may control, but if so how much or how little? The new laws don’t supply clear definitions. For example, what constitutes control: 51%, 75%, or 100%? Obviously, the intention of the new anti-Semite laws is to block free discussion and consideration of these various nuances, period. Why are there are no exceptions possible in the law for scientific inquiry or submission of evidence that might actually support these statements, in full or in part? Our government is clearly violating the first amendment with its dogma meant to stop all questions and free speech on this subject.

Given that the expanded anti-Semite definition includes “beliefs,” we have entered the area of “thought crimes” where hard evidence and facts are ignored. Most important is the fact that these legally forbidden hypotheses

do not require hate, which the law defines as the core attribute of anti-Semitism. Lacking hate, the new definitions (such as merely thinking that Jews control the media, etc.) are truly beyond the scope of the core meaning of antisemite. Therefore, their expanded definition creates a stick to strike down general free speech and debate on *anything Jewish*, and the extent of Jewish control in our culture.

“Congress, the White House, and Hollywood, Wallstreet, are owned by the Zionist. [The Jews are] using their power and they have power in every direction. Power over the White House, power over Congress. Everybody is in the pocket of the Israeli lobbies...there's total control.”

— Helen Thomas, UPI Chief White House Correspondent

When the term anti-Semite was popularized by Wilhelm Marr in 1879 it was used objectively. His objections were of the substantial control Jews held in finance, government, and the press at that time in Germany. Anti-Semitism was an open debate, more matter-of-fact. Marr wrote<sup>1</sup> that:

“The daily press is predominantly in Jewish hands, which have transformed journalism into . . . a business with public opinion; Critique of theater, of art in general is three quarters in the hands of Jews. Writing about politics and even religion is—in Jewish hands.”

**Q: Is Anti-Semitism on the Rise? A: *In the Jewish press, Yes***

**Q: Is Hate on the Rise? A: *No, Facts are on the Rise***

If Marr made his observations today he would face strong censure. Biden’s *Special Envoy to Monitor and Combat Anti-Semitism* Dr. Lipstadt would put him on her watch list and accuse him of fomenting another holocaust. It’s all a form of thought control by way of intimidation, with the label *anti-Semite* being the stick of enforcement via social shame.

It is quite ironic that the Zionist elite have a *favorable view* of the new anti-Semite definition because it creates the appearance of rising anti-Semitism. As Theodor Herzl said:

*“the anti-Semites will assist us thereby in that they will strengthen the persecution and oppression of Jews. The anti-Semites shall be our best friends.”* (More details on this in Chapter Nine.)

The Anti-Defamation League (ADL) states that nation-wide anti-Semitic incidents increased [34 percent](#) in 2021 from the year before. However, in

reality hate is not on the rise; instead, information, awareness and discussion are very much on the rise.

Traditionally, prejudice and hatred, and even truly hateful anti-Semitic expressions have not been torts or crimes; they have been seen as rude or bad behavior, or personal shortcomings based on fear and ignorance. Defamation and other torts have always been actionable in courts, therefore additional “anti-Semite” laws are unneeded and actually harmful—as Justice Brandeis said “the remedy to be applied is *more speech*, not enforced silence.”

### **Facts Produce Rising Anti-Semitism**

Many of the newly-defined anti-Semites are peaceful people, never insulting or attacking anyone, and never intending to be anti-Semite. Unfortunately, some have stumbled across scholarly books, for example those explaining the lack of scientific evidence for the German gas chamber story during WWII. By reading and thinking about these books they become the new “anti-Semites.” (For example, reading books by the authors Butz, Kammerer, Leuchter, Rudolf, and Thorn in the Bibliography at the end of this book.)

Anybody may see the video by the Jewish researcher David Cole showing Auschwitz Birkenau Museum director Dr. Franciszek Piper explain that the so-called gas chambers at Auschwitz were *redesigned* after WWII. Again, viewing and listening to the Auschwitz Museum director will result in being branded “anti-Semitic.”

This obsession with correct Holocaust dogma is affirmed by Dr. Deborah Lipstadt and the U.S. Holocaust Memorial Museum when Lipstadt states:

“The only reason to deny the Holocaust is to inculcate and foster anti-Semitism.” Source: <http://www.ushmm.org>

The **only** reason? This is perfect propaganda. We must ask: *what is the evidence for this statement? What study or survey has shown her statement to be factual?* Without a study or survey we can’t speak with any exactness or confidence on the number of people or the variety of reasons existing for **denying** the Holocaust.

By the way, are those questioning the Holocaust necessarily in denial? The term “holocaust denier” misrepresents so many honest people who are just questioning basic facts. They neither affirm nor deny; they question, they theorize, they investigate, they are open to debate.

Observe how Lipstadt cleverly confuses all those who explicitly *deny* with all those only *questioning* the Holocaust *before* reaching a conclusion.

Secondly, look at Lipstadt's statement. It is bold and absolute as if stated by an all-knowing authority. However, *absolute statements* are problematic and may be considered logically false or invalid. In this case, among all people of the world denying the Holocaust, it must be realized there will not be "only one reason why." Obviously people deny things for a variety of reasons, some reasoning is poor and some very well thought out. Some people do research and gather facts, some follow their emotions, and some just believe what they're told.

Lipstadt apparently thinks her PhD will convince people to believe her unprovable claim that "all people who question or deny the holocaust" have no evidence or facts or rationale explanation for their beliefs, and that the sole reason for questioning or denying must be hate.

Finally, Lipstadt's statement implies that fostering hate (within the defined term anti-Semitism) is inextricably tied to denying the Holocaust. How can *hate* be proven to be *universally required* to arrive at this conclusion? Dr. Lipstadt is mum.

Alas, Dr. Lipstadt does not have any in-depth studies that dig down into the psychology of the who and why of holocaust deniers. Of course she doesn't need any factual proof because as Biden's *Special Envoy to Monitor and Combat Anti-Semitism*, Dr. Lipstadt's sole responsibility is to *combat Holocaust denial*, not find reasons to support denial. Therefore, she has no incentive to find studies or evidence for *reasonably denying the Holocaust*. If she did, she would be officially termed a *self-hating Jew* and lose her job.

If the official Holocaust story is a fact, it will be provable; nobody should be able to disprove any part of it. But if you believe you have disproved it, or even pose scientific questions, then you're a hateful anti-Semite according to anti-Semite laws. This is no different than the dogma of the middle-ages, as in *the Inquisition*.

It is not difficult to see that the new expanded anti-Semite definition and laws violate the First Amendment to the U.S. Constitution, as well as cast a false shame on individuals for offering facts and logical analysis. It is clear that these “Holocaust thought” laws are written as unconstitutional propaganda meant to intimidate those wishing to read, think and speak with facts and logic.

It is up to all of us to challenge these bogus laws. *We the people* control the government in this country, not *We the Jewish Lobbyists and Jewish administrators*. We must think for ourselves and be able to identify misleading propaganda, such as that touted by absolutist Holocaust advocates, such as Dr. Lipstadt. All it takes is reading, asking the right questions, and making our own conclusions, regardless of political pressures. Questioning is the key to escaping the enemy’s matrix of lies.

When we question and condemn the nearly two-hour deliberate attack on the *USS Liberty* 56 years ago by Israeli machine guns, torpedoes and napalm bombs, does that make us *conspiracy theorists* or *anti-Semites*? Not whatsoever; it makes us true, noble and worthy people, ever mindful of the enemy’s war crimes that our own government denies and covers up.

There can be no doubt that today more than ever, the term *anti-Semite* is exclusively a *Zionist smear word* used as a political switch to turn off free speech and thought around the world! **To the lament of our enemy, no amount of law or propaganda can stop critical thinking, questioning, and researching by free people.**

There is nothing anti-Semitic about telling the truth and debating purported facts. No governor, president, or bogus law can tell us what to think. If we express love for our fellow man, but respectfully criticize certain actions or certain beliefs by supplying truthful facts and do not misrepresent those facts, then we are clearly not hateful. However—tolerance has its limits and those limits are set by who you follow, Almighty God above, or the devil below. Therefore, true Christians and patriots are by definition intolerant of unconstitutional and unbiblical viewpoints. This is the enemy’s true complaint.

### **They Start with the Children**

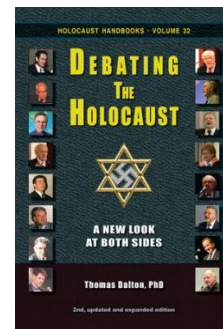
As discussed in Chapter Three, a good example of forcing false propaganda on impressionable school children is the recent anti-Semite

legislation signed by Florida Governor Ron DeSantis. The governor has gone even further with his view on Holocaust education, saying recently:

“We also believe that it is very important that we have very strong Holocaust education . . . throughout the state of Florida. We cannot have people try to whitewash the Holocaust in Florida schools . . . it’s very important that that story is told.”

With some modest research, the governor would know that the Holocaust story has already been whitewashed and continues to be painted over with the latest version of the one-sided, skewed official narrative. The whole and complete story is hidden (whitewashed) behind unanswered questions and unviewed research. The whole truth and nothing but the truth must be laid out to stop any further “whitewashing” of the Holocaust.

Florida and all states ought to consider a program not of just Holocaust testimonials, but also the scientific evidence. Also, since questioning and debate are the best way to get to the truth, the schools should help children embrace critical thinking with books, such as *Debating the Holocaust: A New Look at Both Sides*<sup>†</sup> by Thomas Dalton (PhD.), as well as *Dissecting the Holocaust* by Germar Rudolf. Similar publications are in this book’s bibliography.

Reading books on both sides of the issue would be a first step to discovering the *whole truth* of the Holocaust and prevent any “whitewashing.” After debating, if students conclude the official Holocaust story is true, then they should speak up about the evil. Concluding otherwise, they could cite facts showing why the story is lacking credibility and where the evil actually resides.

The beauty of open debate is that by letting the students see all sides to the issue, they will expose the weak arguments and let the strongest evidence prevail. Therefore, letting all holocaust skeptics voice their opinion (if false) would, with debate, expose the truth of the Holocaust. When Ron DeSantis proposed “strong Holocaust education” he opened the door to a full examination of the issue. If the official story is true, then all facts and evidence must be considered, weighed and judged. *Strangely and Illogically, this has never been done.*



The sad fact is that school systems will never authorize a full and open curriculum to *speak freely about all evidence and facts* on the holocaust. The obvious reason: they are controlled like a hooked fish by the powerful Zionist elite in control of the media and school textbooks.

Returning to the example of Florida's new antisemite law of 2019, most of that new legislation was already on the books, except for a *Jewish section* at the bottom of the new law. It provides quite a list of new examples of "anti-Semite" expressions. Did we need a new section of law just for Jews? It appears to be a double standard as no other ethnic group has received this detailed special attention. *Ironically, this new law appears by its own words discriminatory and racist because it ignores other races.*

Without taking a breath, the Florida legislators drafted yet another Jewish law in January 2023, blatantly appearing to be just for their Jewish friends and patrons. Anti-Semitism is cited three times, yet no other ethnicity or religion is mentioned. The Bill (HR 269) was introduced to outlaw the projection of images on buildings and the distribution of flyers that cite facts on Jewish power (how Jews control the media, banking, government, etcetera.).

To show his loyalty to a foreign land, Ron DeSantis made his fourth trip to Israel to sign the Florida law (and hobnob with some of the richest Jews in the world). DeSantis may be well-meaning in many ways, but he goes along to get along and in the end is just another Jewish puppet pushing so-called anti-hate laws that serve the world elite and their wish to silence the people and the full body of evidence.

Ironically, these creative ways (projected images and flyers) to communicate about Jewish activities wouldn't occur if freedom existed to discuss the issues openly without harassment. But freedom is outlawed because, according to Gilad Atzmon, Jewish power has "the unique capacity to silence any discussion of Jewish power."<sup>†</sup>

At the federal level, it is ironic that U.S. laws coddle the state of Israel's inordinate fear of critical comments, yet Israel has recently legalized

discrimination of all non-Jews in their country with its ***Nation-State Bill***, making Palestinians second-class citizens. Another paradox: recent headlines proclaim that “Jews are Proud to Stand with Refugees,” yet only in the USA; Israel is off limits to non-Jew immigration. These are the same *hypocrites* Jesus referred to many times.

The swinging axe of Zionist political power continues to chip away at our constitutional rights—specifically the right to free speech, critical of Zionists or otherwise. But why? Defamation of character complaints for libel or slander have always been actionable in the courts, and the filing of discrimination complaints has been available to redress wrongs.

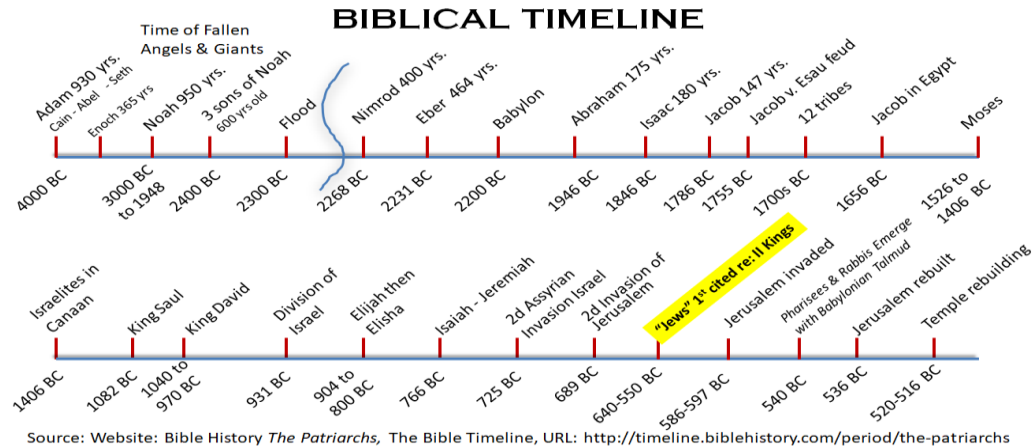
Sanity still exists though. Not every government or college campus is onboard with the unneeded wish list of new laws just for Jews. Furthermore, not every rabbi is in agreement with the Zionist State of Israel. Should they be labeled anti-Semites also? Here is what former Chief Rabbi Freund of Jerusalem said,

“I have already said many times that at times like this, when G-d’s name is being desecrated from one end of the world to the other by the actions of the Zionists and their collaborators, we have a holy obligation to raise our voices. . . and announce . . .we have no connection with these actions. . . it is forbidden for us to do any act to rebel against the nations or force the end of our exile, to take redemption and a state before the coming of the messiah. And certainly it is forbidden to do such abominable acts as have been done [by the Zionists].”

Are the Chief Rabbi’s words anti-Semitic? Unlike Rabbi Freund, many Christians believe the Bible confirms that the 1948 establishment of a Jewish state was a needed first step in God’s plan for the return of Jesus—but where in the Bible is this declared? Supporters of this belief quote passages from Isaiah\* and Jeremiah, however those Prophets are not speaking of *Jewish* people following the Talmud, but only of *Israelites* as Jacob’s descendants in Israel following Mosaic laws. There is a clear disconnect between Jews and Israelites. The Jews and their Talmudic Pharisees did not begin to emerge until around 500 BC, after Isaiah and Jeremiah. A final restoration of Israel occurred in 516 when the temple was rebuilt, not in 1948.

This idea of a “restored” Jewish state stems from the siege of Jerusalem in 597, and then the destruction of the temple in 587 BC. It’s obvious that the prophesized restoration of Israel by Isaiah was fulfilled when the restoration of the temple was completed in 516 BC, not in 1948.

Today a new type of restoration is being pushed as the “the great reset” and “build back better.” This reset appears to mimic the Biblical concepts of “restoration” and “renewal” spoken about by Jesus and the prophets. That *renewal* (or restoration) mentioned by Jesus in Matthew 19:28 is where the Son of Man (or Son of Adam) sits on his throne in a new *divine* Jerusalem. Instead of a *worldly* Zion or an Israeli kingdom with a worldly Messiah as touted by today’s Jews, the new Jerusalem will be divine and come at the end of this age. It will be a new beginning, a new Jerusalem and a new Heaven as cited in Revelation 20 and 21. Netanyahu’s *restored* war-torn Israel created in 1948 is a false worldly image of the true divine Biblical image of Jerusalem which will be on a clean restored earth with delight and joy and where *the sound of weeping is heard no more.* (paraphrase Isaiah 65:17-19)

According to the rabbi Lynn Gottlieb Israel is currently home to:

“great injustices against Palestinians—based upon anti-Semitic theological/political idea that Jews must be restored to *their homeland* in order for the Second Coming of Jesus to occur.”†

This is what Christian evangelicals (falsely) believe is a prerequisite for Christ’s return. The concept is false because there is no Biblical justification for a *worldly* new Jerusalem.

Florida and other states have focused their view of anti-Semitism in terms of “Jews” and “Israel” but that shifts the issue away from *Zionists*—those real subjects of the numerous so-called “anti-Semitic” comments. Zionists are only a small fraction of the world Jewish community. Criticizing Zionism does not necessarily include criticism of the common Jew.

### **Jews Control Media, But Now Unlawful to Corroborate**

As mentioned above, the IHRA and the Florida law define anti-Semites as those believing:

1. A world-wide Jewish conspiracy exists
2. Jews control the media
3. Jews control the economy
4. Jews control the governments
5. Jews control societal institutions
6. The Jew Holocaust was an invention or at least an exaggeration

The Anti-Defamation League (ADL) states that about 10% of U.S. citizens believe the following are probably true:

- Jews have too much power in international financial markets
- Jews have too much control over the global media
- Jews talk too much about the Holocaust
- People dislike Jews because of their behavior

If honesty and free speech existed, it would be said that most of the statements in 1 - 6 above are common knowledge; Jews are successful business people. The recognition of Jewish ingenuity, intelligence and business success is certainly not anti-, but clearly *pro-Semitic!*

### **Jews Hide Their Ethnic Identity to Hide Their Control of Media**

Here are two brief examples of Jewish control of the media (there are many more): **Reuters News** was founded in 1851 by Paul Reuter. However, Reuter was born *Israel Beer Josaphat*, the son of a Jewish Rabbi. Many Jewish TV stars and personalities adopt Anglo-Saxon names, e.g. *The Daily Show* was hosted by Jon Stewart, a Jew. Stewart's birth name is Jonathan Stuart Leibowitz. Harry Cohn (1891-1956), was the Jewish founder of Columbia Pictures. The “American” comic Jerry Lewis was the Jew Joseph Levitch. The iconic movie star Kirk Douglas was

born to Jewish parents as Issur Danielovitch. Andrea Mitchell of NBC News is Andrea Rubenstein, the Jew who married the Jewish FED chairman Alan Greenspan. In 1925 the atheist Jewish author Alisa Rosenbaum came to America and became Ayn Rand. The Jewish Satanist Anton LaVey was born Howard Stanton Levey. The list goes on and on—many Jews hide their identity. Overtly and covertly, they have controlled the media since the early 1900s.



Why are governments writing laws to stop people from quoting the truth that Jews work hard and have inordinate success? Is it modesty or perhaps Jewish doctrine that requires denial of their many accomplishments? They appear to want their privacy, to always work behind the scenes and out of the spotlight. The auto manufacturer Henry Ford noted this by saying:

“There is a strange confusion in the Jewish mind, a struggle between a desire to remain unidentified and a desire to be known. Sometimes they measure friendship by the depth of the silence about their being Jews; sometimes by the amount of open laudation. To say a man is a Jew is sometimes to be vilified as an "anti-Semite," and sometimes to be honored as "a friend of our nation."

That the Jews most certainly desire to keep a low profile was prominently displayed in two court cases where Robert Edmondson was alleged to be an “anti-Semite” and consequently sued by prominent Jews for defamation in the 1930s and 40s. Both cases were dropped when Edmondson subpoenaed some very high profile New York City Jews to appear in court. They refused to appear and withdrew their pretentious complaints.

For all their attempts at privacy, it is difficult to ignore the blinding fact that Jews control the U.S. media and entertainment industries.

It is interesting that while American Jews have attempted to assimilate into an Anglo Saxon Christian culture, the European Jews migrating to Palestine have attempted to become more authentic in terms of a Hebraic

identity. For example, the father of Benjamin Netanyahu, like many others, changed the family name to appear as Hebrews, from the *Jewish* Mileikowsky to the *Hebraic* Netanyahu. Thus, in a sense one could say imposters have taken over the holy land. Jews appear to be the ultimate identity thieves.

### **The New Anti-Semite Laws Warn of *Mythical Beliefs***

Remarkably, some laws such as Florida Statute 1000.05 claim it is “anti-Semitic” when “**making allegations such as...the myth that Jews control the media.**” In reality, legislators cannot define what beliefs are myths and politicians cannot control what we believe. Myths and folklore are not the province of legislative bodies and cannot be a matter of legal statute. If that were so, their next law may prohibit the dangerous myth that a strong correlation exists between the Easter Bunny and chocolate-coated eggs.

Laws’ prohibiting “Jewish” myths is another proof of our broken culture. Even the *Encyclopaedia Judaica* indicates that Jews do indeed control most of the media. According to Neal Gabler, there is no myth about the obvious fact that Jews control the media and Hollywood.\*

As mentioned previously, the Jewish *Encyclopaedia Judaica* clearly states under its *Television and Radio* section that the top three U.S. television networks are **Jewish founded and controlled**. David Sarnoff, a Jew, founded NBC in 1926. William Paley, a Jew, founded CBS. Leonard Goldenson, a Jew, started and ran ABC as its president. The *Judaica* also references a list of dozens of top print publishers in America that are Jewish owned and/or controlled.

The new expanded discrimination laws intend to discourage us from realizing the obvious fact that **Jews control many aspects of this world.** They want us to obediently ignore reality. Of course the ruling bodies all know it’s perfectly true. The quote below confirms this fact. The founder of Jewish Zionism wrote about the subject in the very early 1900s.

"The wealthy Jews control the world. In their hands lies the fate of governments and nations. They set governments, one against the other, and by their decree, governments make peace (or war). When the wealthy Jews play, the nations and the rulers dance. One way or the other, they (the Jews) get rich."

Herzl said Jews controlled the world of 1896. How much more today? Today of approximately 200 countries in the world, the Jews control the banking systems of at least 160 of them, or 80%. The only prominent countries without Jewish control are Iran, Syria, N. Korea, Cuba, Russia, Venezuela, China, Iceland and Hungary. Of course, these countries are on their shopping list.

The recent anti-Semitism laws around the country, such as F.S. 1000.05, all say they don't intend to prohibit free speech under the First Amendment, but they do exactly that—they shame human rights activists, including some Jews, e.g., those who justifiably petition against Israeli aggressions, mistreatment, and even genocide of native Palestinians.

Criticizing Israel's state ideology, Zionism, is not the same as anti-Semitism. This is because Zionism is a rogue element that skirts the main tenants of Orthodox Judaism and focuses on power, politics and acquisitions. Many Jews are not Zionists. Therefore, criticizing the tactics of Zionists around the world is not anti-Semitic; it is criticism of aggressive, violent, or tyrannical *behavior* only. For instance, being anti-war, anti-abortion, or anti-pornography is not necessarily anti-Semitic or anti-Jewish.

According a recent poll, 25% of Jews in the U.S. feel that Israel is an *apartheid state*\*, i.e., Israelis practice racial or religious discrimination.

The fact that Israel is a racist state is evidenced by their 2018 "Nation State" law that made about 1.5 million Palestinian residents 2d class citizens, forbidding them full rights as those of Jewish Israeli residents. Are U.S. Jews that affirm this fact also anti-Semitic? Is the *Jewish Voice* for Peace anti-Semitic for wanting peace and justice in Palestine?

In addition to the packed house above, Jews too numerous to list have controlled every aspect of the Covid health scam, the engineered illegal immigration crisis, the abortion industry, and the vast majority of U.S. media in every format. According to author and political analyst Mitchell Henderson, Jews are 100% in control of the U.S. government. As mentioned above, past Chief White House correspondent Helen Thomas said the same.

Of course, our Jewish-controlled government turns a blind eye to Israel's crimes and racist policies with regard to its Palestinian residents. Israel is a land of walls, checkpoints, and discrimination. For many, Gaza is an open death camp with random bombings and shootings day and night. ### **Do Jews Control the Economy?**

Jews have been traders for centuries. They have a long history of commercial activities and are experts at commercial trade around the world. Wealthy Jews such as the German-Jewish immigrant Paul Warburg created the Federal Reserve in 1913 with the help of their political agents.<sup>†</sup> *The Federal Reserve* is a deceptive name; it is not federal and has no reserve. Instead, the Fed is a private Jewish-owned central bank in Washington, D.C. with twelve regional branch banks that manipulate fiat currency to enrich the owners at the expense of the American people.

"We are led to believe the government controls the Federal Reserve System and we have control over it, but in truth *the Fed regulates the government...and has control over it*. The Fed and the monetary forces that they represent are actually the ruling powers of our society and government and not the people we elect to congress."

The Fed's "U.S." dollar bill displays their all-seeing eye on the reverse side. Under the eye, it does not say "1776 - United States Declaration of Independence." Instead, their 1776 (MDCCLXXVI) represents the founding of their *Novus Ordo Seclorum*, the guiding principal of their *Illuminati*, founded in 1776 with the goal of creating a *new world order*. This *Illuminati* was not a light bulb company; it was (and is) absolutely an historical and factual entity. The *Illuminati*'s anticipated new order would only be possible with vast amounts of money. Therefore, Jews have attempted to control our economy since the days of Andrew Jackson, the last president to protest their manipulating schemes.

How will they prevail? They fervently lobby for anti-Semite laws that say, in effect, *since Jews are God's chosen people and can do no wrong in any way, don't even think about what Jews are doing*. Professional criminals can only dream of such a defense strategy ordained by God Almighty.

In summary, history is filled with so-called “anti-Semites” opposing certain Jewish doctrines and behaviors inspired by their Talmudic books. Examples are Jesus of Nazareth, St. Augustine, Martin Luther, European kings, Adolf Hitler, Henry Ford, Charles Lindbergh, Richard Nixon, Mel Gibson and *countless millions of others*. But why would European Christians throughout the ages criticize Jews if Jews were *God’s chosen people*, those supposed to be the foundational people of the Bible and Western Civilization? We must know the answer. The following chapters layout some stinging facts in this regard.

As for the Jews, they collectively say they are maligned primarily due to their religious beliefs and practices—and at the hidden root of their explanation, they are right. As Bernard Lazare explains in his book, *Antisemitism: Its History and Causes*:

“If this hostility, this repugnance had been shown towards the Jews at one time or in one country only, it would be easy to account for the local causes of this sentiment. But this race has been the object of hatred with all the nations amidst whom it ever settled. Inasmuch as the enemies of the Jews belonged to diverse races . . . it must be that the general causes of Anti-Semitism have always resided in Israel itself, and not in those who antagonized it.” \*

## **Why Do We Support Israel?**

How does a foreign country like Israel get the entire U.S. Congress as well as most of their constituents to support them with a nearly instinctual zeal? First, Jews control the media\* and have been the molders of public opinion in the U.S. for at least 125 years. This was even a concern written about by Wilhelm Marr in 1879 Germany. Israel shapes public opinion employing many strategies: for example, utilizing social diplomacy and cultural diplomacy. Besides controlling much of the press, they employ online warriors such as Act.IL, UNIT 8200, and Canary Mission. Thousands of students are employed to promote Israel online and silence criticism of anything Jewish, from editing and locking Wikipedia pages to challenging Facebook posts. To lock down the U.S. Congress, they assign each member an “AIPAC advisor” (American Israel Public Affairs Committee) to ensure Israel’s agendas are always foremost in the minds

of “our” government officials. Additionally, anyone not in line with Israel’s policies may face the charge of “anti-Semite” or one of the latest state or federal *anti-Semite* hate speech laws.

A second major strategy used by Jews to garner support is their relentless marketing of themselves as worthy and admirable. This involves two primary forms. 1) Foremost they are victims and victims always deserve support. They promote this through dozens of Holocaust museums, and more are being built. 2) Their most moving plea is the repetitious but unproven claim of being the bonafide special race, the *chosen people*\* of God (doing God’s will in Palestine to cleanse the land of the native population). As owners and masters of media management, they employ applied psychology to mold public opinion—focusing on what works to gain compassionate support, e.g., repetition of emotional pleas, even words of fear and shame have their place. For over one hundred years, starting with the Jewish-printed Scofield Bible in 1909, they have been reiterating their agendas via the worldwide press agencies they own. This is a form of mind control and it works.

Specifically, the Bible says ‘Abram the Hebrew’ (Genesis 14:13) was given certain land (Genesis 15:18-19) and the future Talmudic Edomite Jews (first appearing about 500 years before Christ) were not chosen and not part of any covenant and thus not given anything.

To summarize, the marketing strategies above have conditioned us to support the militant state of Israel’s fear that they are surrounded by “terrorists.” But even with their media wizardry, many Americans still have questions. The foremost question thinking Americans should ask remains: *what are the real and true benefits to Americans for our vast money and resources given to the Jewish state?*

Donald Trump has lately warned of American “Jew haters” (even Democratic Jews) that apparently want to question or criticize various Jewish agendas. *Jew hater* is an emotional psyop term that Trump uses to emphasize: don’t question Israel! The newly-elected president is apparently worried that our bond with the Jews could brake; if so, he should provide solid reasons for his concerns and in what way a brake would hurt Americans. Pitiably, instead of giving concrete reasons why we should bond with the Jews, he resorts to this psyop tactic, leaving many thinking Americans wondering why we need to continually support a militant, parasitic state that provides nothing in return.

As former president Richard Nixon stated, *we have no strategic interest in the land of Israel.*\* Nixon stated flatly that we support Israel primarily due to three reasons: the image of Jews being related to Christians in their *Judeo-Christian* heritage; Israel's image as a moralistic *democracy*; and due to the *holocaust* allegation.

But what if all three of these perceptions are myths with no basis in fact (as shown in the last half of chapter three concerning #1 and #2, and in chapter ten concerning the Holocaust claim)?

What justifies blind support of a foreign country once we fully consider the facts and realize that their oft-repeated claims lack evidence or can be proven false?
